### 1 When and where is the RWC Annual General Meeting?

## 2 Will there be a live webcast of the meeting?

RWC will not be providing a webcast of the meeting.

### 3 What do I need to do to register to attend?

Shareholders and visitors should arrive before the commencement of the meeting and register upon arrival. Pre-registration is not required.

#### 4 What impact will the COVID pandemic have on holding the meeting?

The General Meeting will be held as an in-person meeting. The health and safety of our shareholders, employees and the broader community are extremely important to the Company's Board and management. The Company will comply with any applicable COVID-19 restrictions in conducting the meeting. Persons attending the General Meeting will be required to comply with COVID-19 protocols in place at the time.

If COVID-19 circumstances change in a way which impacts the holding of an in-person General Meeting, the Company will provide an update by announcement to the ASX and on its website. Shareholders are encouraged to check the ASX announcements platform (ASX Code: RWC) and the Company's website for any updates in connection with the General Meeting.

### 5 How do I vote or ask a question at the meeting?

Shareholders entitled to vote at the meeting will be given a reasonable opportunity to ask questions in connection with the management of the Company.

The Chairman will announce when questions can be asked and when the voting period opens and closes.

#### 6 How do I vote or ask a question prior to the meeting?

Shareholders are encouraged to vote or submit written questions prior to the meeting.
